

#### ISPLS SCHOLARSHIPS - Reasons to Give

#### **TECUMSEH CHAPTER NEWS**

The Tecumseh Chapter of ISPLS has been active over the past year. Meetings in March and September were attended by 15 perons and a May meeting saw 8 attendees. The meetings are generally held at The Oaks restaurant just north of West Lafayette on U.S. 52.

Among the topics of discussion through the year were the possible establishment of a speakers bureau, a booth at the Feast of the Hunter's Moon, work on an EDM Baseline, and the mailing of a letter to the political parties of Tippecanoe County.

The Chapter also formed a committee to assist and make suggestions to the Tippecanoe County Surveyor on the Section Corner Perpetuation Program. Among the suggestions prepared were: 1) update, inventory, and index existing records; 2) concentrate on searching for section corners which do not fall on public roads; 3) prepare a standard format or form which local surveyors could use to turn in section corner information; 4) utilize the Purdue Student Chapter of ISPLS/ACSM in searching for corners; and 5) develop a computer based data bank for section corner and land information.

Tecumseh Chapter made a strong program out of the NSPS Trig Star at six local high schools. Members of the Chapter visited all six Tippecanoe County high schools and sponsored Trig Star competitions at each.

At the September meeting the following persons were nominated to serve as officers next year: President, Wes Crawford; Vice-President Lee Bender; Secretary-Treasurer Steve Murray.

Programs this year included "Survey-Order Processing" and "Foundations of an Information Cadastre for Purdue University".

#### **BUSINESS TRAVEL EXPENSES**

Employes who account in full to their employers for company-paid to the IRS, and the employers do not have to report the payments they made to employes. But what about reimbursements by companies of travel expenses incurred by nonemployes- independent contractors such as lobbyists, press agents, attornies and the like? Those payments, says the IRS in a new ruling, recorded judgement against a former also need not be reported if the contractor makes a proper accounting to the paying company.

#### **BUSINESS USE OF VEHICLES**

Executives who use their business vehicles for personal use as an untaxed benefit may soon have to do some explaining to the IRS. says Runzheimer & Company. The Tax Reform Act of 1984 has made it more difficult to deduct automobile expenses for business use. It's no longer good enough merely to estimate the amount of personal vs. business use. Instead. an accurate log must be kept of all business miles, plus an accounting of the number of days the car was used for business.

Nearly 40 percent of all companies fail to keep detailed logs on personal use of cars driven on business by their employes. But they will have to do so starting in January, when new tax rules take effect.

#### TITLE ABSTRACTORS LIABILITY

Real-estate title abstracters have a liability not only to the party that travel expenses do not have to account contracts for their services, but also to third parties who may rely on the abstract in a particular property transaction. says the Florida Supreme Court. It allows a title-insurance company to recover damages it paid bacause of an abstracter's alleged negligence in failing to discover a owner of the property, and says other third parties, such as lenders and tenants, are similarly covered. Liability, however, does not extend to parties that might use the abstract in a later transaction.

ISPLS President Jake Hall and President-Elect Bob Bigelow attended the Great Lakes Regional Council Meeting held September 10, 1984 at the ASP-ACSM Fall Convention in San Antonio. The states of Indiana, Michigan, Ohio, Illinois, Wisconsin, Minnesota and Iowa are represented on the Council.

#### REGISTRATION BOARD ADOPTS RULES CHANGES

The Indiana Registration Board for Engineers and Land Surveyors made several important, far reaching changes in its regulations at its November 16th meeting.

In response to a letter from ISPLS President Jacob Hall, the Board voted unanimously that the following definition of "responsible direction and supervision" be submitted under the general provisions of the Board's regulations:

> "The term Responsible Direction and Supervision means direct control and personal supervision of land surveying work."

This definition is recommended by the National Council of Engineering Examiners. The adoption of this definition represents a major step forward from last year when the Board's administrative officer offered the opinion that "there is no litmus test for Responsible Direction and Supervision..." (See pages 10-11, Volume 11, Number 2, Spring 1984, Hoosier Surveyor)

Additionally, the Board unanimously passed a motion to publish a new regulation of the Indiana Board which will state as follows:

> "Effective January 1, 1989 the minimum education requirements for Professional Engineer and Land Surveyor applicants be no less than an earned bachelors degree".

In conjunction with this motion, several other resolutions were passed. One rescinded previous Board actions stating that the qualifications for PE and LS applicants without a degree be 12 years of practical work experience. Another motion was passed to make a proposal to amend the current Board Rule #2 by supplementing the education/experience guidance table used in the 1971 Registration act book.

Finally, it was unanimously approved to publish into state law the latter resolution regarding the usage of the education/ experience table.

These actions were taken during a personal appearance by Deputy Indiana Attorney General Fred Bremer.

#### 200TH ANNIVERSARY SYMPOSIUM

#### THE LAND ORDINANCE OF 1785

The Land Ordinance of 1785 established the rectangular Public Lands Surveying System (PLSS). The Bureau of Land sanagement (BLM), Department of the Interior, as the statuatorily designated surveying agency for the public lands and other Federal lands is coordinating a national commemoration.

With tentative co-sponsorship of the American Congress on Surveying and Mapping, (ACSM), the Civil Engineering School of Purdue University and the Indiana Society of Professional Surveyors, BLM is planning an historical symposium September 10-11,1985 in conjunction with the Fall Meeting of the ACSM in Indianapolis IN.

BLM and other co-sponsors will consider papers under the following General Headings: (1) Federal Land Policy and the Genesis of the Land Ordinance of 1785; (2) Public Land Surveying 1785-1820; (3) The Management of Public Land Surveying; and (4) Special Topics

Specific topics include: The Western Lands and the National Interest 1776-1784; New England Settlement and Surveying; Southern Settlement and Surveying; Compromise Ordinance: Southern Settlement and New England Surveying;

Establishing the Point of Beginning; Ohio: the Crucible; Maturity in Indiana;

The Office of Surveyor-General; Contract Surveyors; Federal Surveyors; Impact of the Public Land Surveying on Real Property Law; The Army Standing Guard 1785-1787; Public Lands Surveying: The First Natural Resource Inventory; Surveying Fraud; Public Land Surveying in Alaska; Export of Public Land Surveying; Public Land Surveying and High Tech.

Suggested additions or substitions welcome. Presentations will be scheduled from 30-45 minutes. Papers will be published in the <u>Proceedings</u> if paper furnished in ACSM format by June 1,1985. (One day of the registation fee is waived for authors on day of their presentations which will make a copy of <u>Proceedings</u> available at registration.)

#### HIGHLIGHTS OF BOARD OF DIRECTORS MEETING

August 18, 1984: ISPLS Headquarters, Indianapolis

Attending: Jake Hall, Larry Manning, Gary Kent, Pat Cunningham, Lee Bender, Rollyn Blankenbeker, Bob Bigelow Not Attending: Jud Rouch, John McNamara, Don Bengel, Ray Tappan, Carl Anderson Also Attending: Dan Pusey

-A finance report by President Hall showed total society cash assets of nearly \$39,000 as of August 17, 1984. Membership dues have been paid much more rapidly this year than in the past. -The ISPLS share of profits from the 1984 Tri-State Convention

will be approximately \$6,000.

-The 1987 ISPLS Convention will be at Purdue University in West

Lafavette. -59 persons attended the Summer Picnic held on July 28th near

Noblesville. -The consensus of the Board is to exempt surveyors employed by the Indiana DOT from the proposed Continuing Education Legislation. Representative Klinker has once again agreed to sponsor

the bill.

-The consensus of the Board is to try to get a senator and representative to submit legislation for a requirement of a four-year college degree in order to qualify for the LS Exam. The consensus of the Board is that this requirement should become effective ten years after enactment of the legislation.

-Membership Committee Chair Joe Blevins is currently working on

the publication of a new membership roster.

-The LS Exam Committee is performing the task of writing and grading the exam not as a committee of ISPLS, but as individuals. There is no contract with the State at this time. The Committee has indicated that it may discontinue this work unless the contractual details can be worked out.

-A motion was made, seconded and carried directing that the resolution asking for a newsletter from the Registration Board

be sent to said Board.

We are happy to welcome Hickerson Instrument Company back as a sustaining member of ISPLS.

Former ISPLS President Jud Rouch has taken the position of Coordinator of Associate Degree Land Surveying Program at the University of Arkansas at Little Rock. We thank Jud for his work for the Society over the past few years and wish him luck. IUPUI Professor David Wahlstrom has taken a new position at a university in Texas. We appreciate his work for ISPLS and wish him well.

Patrick Cunningham was elected President-Elect of ISPLS in the recent election. He will succeed to the Presidency in 1986 following Bob Bigelow's tenure.

The ISPLS Fall Workshop on survey measurement analysis saw 26 persons in attendence. Reports are that it was an excellent program. The workshop was held in Indianapolis on November 9-10.

ACSM "Field Notes" reports that the Federal Housing Administration's HUD/FHA Form 2457 will be reviewed and revised in early 1985. A HUD official has acknowledged that the form does not provide the information needed by the agency, is not consistent with many state laws and contains a certification which may result in serious liability exposure to the signator.

"Field Notes" also reports that the Federal Emergency Management Agency's National Flood Insurance Program flood elevation certification falls in the same category. An ad hoc committee of trade associations and professional societies involved in the program has been formed to provide input in every aspect of the flood program. ACSM or ASP members with information on problems with any aspect of the program are encouraged to contact the ACSM member of the committee Rodger Phelps (Sulfur, Louisiana 318/525-8353) or the ASP member Richard Crouse (Gaithersburg, Maryland 301/948-8550).

The Bureau of Land Management, Purdue University, and ISPLS will be co-sponsoring a symposium on the 200th anniversary of the creation of the U.S. Public Land Survey System. The symposium will be conjunction with the ACSM-ASP Fall Convention in Indianapolis the week of September 8, 1985. Look for a Call for Papers for this important program elsewhere in this issue.

Additionally, the National Aeronautics and Space Administration and the American Society of Photogrammetry will be co-sponsoring the final Landsat Image Data Quality Analyses (LIDQA) Symposium at the Fall '85 Convention.

#### LEGISLATIVE UPDATE

The Consulting Engineers of Indiana is planning on introducing a bill in the Indiana Legislature which will reduce the statute of limitations for engineers and architects. According to the CEI, twenty-one states have statutory periods of between four and eight years. Indiana's current law provides for ten years from the "date of substantial completion." The proposed legislation would tighten-up the definition of "date of substantial completion" and would also reduce the number of years of the statute from ten to seven years under some circumstances and ten to five years under others. The CEI claims that the current statute creates a large burden on the design professional both legally and because of insurance premiums.

The Consulting Engineers will also be introducing a Mini-Brooks Bill which would require state and local government agencies in Indiana to select engineers, architects and surveyors based on qualifications with fees to be negotiated later. Such legislation would put Indiana in line with the federal Brooks Bill which requires the same selection procedure.




