



COMPANY VEHICLE GUIDE

Company vehicles are unique in that they are designed and modified along the lines of the private vehicle but are modified in certain areas to provide for situations rarely encountered in private motoring.

- 1. They travel faster in all gears, especially reverse.
- 2. They accelerate at a phenomenal rate.
- 3. They enjoy a much shorter braking distance.
- 4. They have a tighter turning circle.
- They can negotiate poor road surfaces and deep holes at twice the speed of private vehicles.
- Water, oil, battery and tire pressures do not need to be checked as often as private vehicles.
- 7. The floor is shaped like an ashtray.
- 8. They only burn gas with the highest octane rating.
- 9. They do not require to be garaged at night.
- They can be driven for up to 200 km. with the gas gauge showing empty and oil warning light flashing.
- 11. They need cleaning less often, especially the inside.
- 12. The suspension is reinforced to allow for the carriage of worn out iron pins, useless chunks of pipe and snow machines.
- 13. They have specially designed transmissions which allow the engaging of reverse gear while the vehicle is still making forward progress.
- The rims and tire walls are designed to allow for colliding with or jumping over gutters, curbs, median strips, ruts and logs.
- 15. Unusual and alarming engine and transmission noises are easily eliminated by the adjustment of the fitted radio volume.
- 16. No security is needed. Company vehicles can be left anywhere unlocked with the keys in the ignition and running, and transits and EDM equipment laying in the back.

Field Technique

Sixteen or more years ago, Sandstone Sam of Geotimes fame reported that in an exam in Field Geology, a geology major who had had summer field experience answered the question, "How to measure the height of a cliff with an altimeter" by saying there are four ways:

- 1. Tie a string to the altimeter and lower it from the top of the cliff to the base; then measure the string.
- 2. Measure the thickness of the altimeter, then place the instrument against the cliff, mark the top with a pencil, raise the bottom to the pencil mark, and repeat the procedure until the top

of the cliff is reached, tally the number of marks and multiply by the measured thickness of the altimeter.

- 3. Using an accurate stop watch, drop altimeter from top of cliff and time its descent to the base of the cliff. Apply the standard formula, $S = \frac{1}{2}$ gt².
- 4. (And least accurate) Read elevation from altimeter at base of cliff, and read elevation again at the top of the cliff. The difference between the two readings should equal the approximate height of the cliff.





Article I Members

SECTION 1. Qualification of Members

The members of this corporation shall be those persons who (a) shall be eligible for membership under provisions of section 3 and (b) shall have been elected to membership upon the recommendation of the membership committee by the board of directors by the vote of the majority of the directors who were present at the meeting of said board which is attended by a quorum of the directors.

SECTION 2. Classes of Members

The members of this corporation shall be classified as follows:

- 1. Member
- 2. Junior
- 3. Associate
- Student
- 5. Life
- 6. Sustaining
- 7. Honorary
- 8. Firm

SECTION 3. Qualifications and Privileges

- Member: A member of this corporation shall be limited to registered land surveyors in good standing with the Indiana State Board of Registration for Land Surveyors. A member shall be eligible to vote, hold office and to participate fully in the affairs of the corporation.
- 2. Junior: A junior membership will be granted to those non-registered individuals who are endeavoring to make surveying their chosen career. A junior member is entitled to vote and participate fully in the affairs of the corporation but shall not be entitled to hold office.

Junior members shall, at such time that they become registered land surveyors in good standing with the Indiana State Board of Registration for Land Surveyors, become members without further vote of the board of directors of this corporation.

- 3. Associate: An associate membership will be granted to those individuals who qualify under the following provisions:
 - a. Anyone who is associated or affiliated with the land surveying profession but is not otherwise pursuing registration or,
 - b. Any non-resident who is registered and in good standing as a land surveyor.

As associate member is not entitled to vote, or hold office but will receive Newsletter and be invited to participate in meetings.

4. Student: A student member shall have the same eligibility requirements as those of a junior member, except that this class of membership shall apply for a period of four (4) years only.

A student member is not entitled to vote or hold office, but will receive Newsletter and be invited to participate in meetings.

5. Life: Any person holding member status shall be eligible to petition the board of directors to change his membership to that of life member. If the board of directors finds that the member so petitioning has reached the age of 65 years and has been a member of this society for at least 10 years, it shall grant the petition and the member will become a life member. If the board of directors finds that the member so petitioning has not fulfilled the above requirements, the board may grant a petition if it finds that the member has retired from active practice for reasons of health and is no longer engaged in land surveying.

Life members shall be furnished with a life membership card and certificate and such membership shall take effect upon approval by the board of directors. Life members shall not be subject to payment of dues, but shall enjoy all the rights and privileges of full membership in this corporation.

- 6. Sustaining: Any individual, partnership, or corporation who or which are engaged either in the manufacture or distribution of surveying instruments or equipment, or in the compilation or reproduction of maps, or in the performance of services for land surveyors. A sustaining member is not entitled to vote or hold office, but will receive the Newsletter and other benefits, as approved by the board of directors, and will be invited to participate in meetings.
- 7. Honorary: Any member of this corporation may propose to the board of directors the name of any individual for honorary membership. The individual proposed for membership may or may not be a registered land surveyor, but shall be chosen for contribution either to the professional interest of the corporation or by such acts of distinction to the government or the people. Such designation requires the approval of two-thirds (%) of the board of directors.

Honorary members shall be exempt from payment of any dues and shall be entitled to all privileges except the right to vote or hold office.

8. Firm: Those firms who have registered members who are actively engaged as consultants in the field of land surveying in Indiana.

The dues for a firm member shall be calculated on the basis of the number of personnel, including principal's registered surveyors, designers, draftsmen, technicians (excluding part-time employees), clerical and all other employees on the firm's payroll for the past calendar year. In case of an engineering-land surveying firm, the prorated portion of personnel concerned with, or in general support of the surveying function shall be counted.

SECTION 4. Expiration: Each class of membership in this corporation shall automatically and without any notice or hearing or other action by anyone, expire on the thirtieth (30th) day of June of the year in which such member shall have failed to pay the annual dues payable by him for such year, unless said member shall have paid said annual dues on or before the thirty-first (31st) day of August. The board of directors may in its descretion, suspend members becoming unreasonably delinquent and may reinstate delinquent members.

SECTION 5. Expulsion: If and when the Ethics Committee shall notify the treasurer that any member either (1) has ceased to be eligible for membership in the class in which he is a member, or (2) has been found guilty of any felony, or (3) has violated any provision of any Code of Ethics, therefore; adopted by this corporation, or (4) has willfully or repeatedly obstructed any purpose or proper activity of this corporation, or (5) has been guilty of any other conduct detrimental to either this corporation or the profession of land surveying, then the secretary shall mail, by registered or certified mail, return receipt, to said member written notice (specifying one or more of said grounds for expulsion) that said member will automatically and without any further notice or hearing or other action by anyone, be expelled from membership in this corporation on the thirtieth (30th) day following the date of the mailing of such notice, unless said member shall show cause, in a written statement delivered to the secretary within thirty (30) days following the date of said mailing why said member should not be expelled from membership. If and when the secretary shall have received any such written statement of cause, he shall notify said member of the time and place of the next meeting of the board of directors when and where said member may be heard with respect to his or its expulsion. After said hearing, said member

may be expelled by the board of directors, said expulsion may be appealed to the next annual meeting of the members held not earlier than thirty (30) days after such expulsion, and such expelled member may be reinstated by the votes of two-thirds (2/3) of the members who vote on a motion to reinstate said former member.

SECTION 6. Property Rights: No member as such shall have any right, title or interest in or to any property of this corporation. Upon the death or dissolution of any member or any other expiration of any membership or the expulsion of any member, no payment of any kind or amount shall become payable by this corporation to the former member whose membership has expired or who or which has been expelled.

In the event of dissolution of the corporation, the remaining assets, if any, shall be distributed to an organization or organizations organized for the same or similar purposes as the corporation.

SECTION 7. **Dues:** Unless otherwise adopted by the board of directors, there shall be no entrance fee charged for admission to the corporation.

The annual dues for each fiscal year shall be payable immediately upon receipt of the dues notice.

Honorary and life members shall not be subject to the payment of any dues assessed under the provision of this section.

Article II Membership Meeting

- SECTION 1. Annual Meeting: An annual meeting of the members of this corporation shall be held once in each fiscal year at such an hour and on such date and at such place as shall have been determined by the board of directors.
- SECTION 2. Additional Meetings: Additional meetings of the membership may be called by the board of directors, and shall be called by the board of directors, upon the written request of fifty (50) voting members. The secretary shall cause written notice of the hour, date, place and purpose(s) of each additional meeting to mailed to each member not less than ten (10) or more than thirty (30) days before such meeting. No business shall be transacted at any additional meeting other than that which is designated in the purpose(s) of said meeting as set forth in call and notice of said meeting.

SECTION 3. Conduct of Meetings: All meetings of the membership shall be presided over by the president or, if he is not present, by the vice-president or, if he is not present, by the secretary or, if he is not present, by the treasurer or, if none of the officer's are present, by a chairman to be chosen at the meeting. The secretary or an assistant secretary of the corporation, or, in their absence, a person chosen at the meeting, shall act as secreatary of the meeting. On all matters coming to a vote, each member, junior member and life member shall be entitled to one vote and all questions shall be decided by a majority vote of the voting members present, unless otherwise provided by law, the Articles of Incorporation, or by these By-laws. All meetings shall be in accordance with "Robert's Rules of Order-Revised."

Article III Officers

- SECTION 1. Election: The board of directors shall hold an organizational meeting in the month of July each year to elect from the board of directors, a president, vice-president, president-elect, secretary, and treasurer. The board of directors shall also elect a delegate and an alternate delegate to A.C.S.M. both of whom may or may not be a member of the board of directors. However, said delegate and alternate shall be members in good standing as provided in Article 1, Section 3 of these By-laws.
- SECTION 2. **Term of Office:** The term of office of all officer's shall be one year (July 1 to June 30th), but any officer may be removed from office at any meeting of the board of director's by the affirmative vote of two-thirds of the directors then in office, whenever it is in its judgement that the business interest of the corporation shall be served thereby. The board of directors shall have power to fill any vacancies in any office occuring for whatever reason.
- SECTION 3. President: the president shall be the principal officer of the corporation and guide it's functions. He shall preside at all meetings of the membership and board of directors. He shall have no vote in any matter coming before the board of directors, provided however, in the event of a tie vote, he shall cast the deciding vote. He shall provide the secretary with a copy of all official correspondance which he may conduct for the permanent record of the corporation.

- SECTION 4. Vice-President: The vice-president shall in the absence or disability of the president perform the duties and exercise the powers of the president and shall perform such other duties as the board of directors shall prescribe. The vice-president shall also be the parliamentarian of the corporation and in all matters of parliamentry procedure coming before the board of directors, his shall be the deciding voice.
- SECTION 5. Secretary: The secretary shall take or supervise the taking of complete minutes of all meetings of the members and of the board of directors. He shall have custody of the corporation's minute book and of it's corporate seal, if any. Submit to the annual meeting of the members a report covering the business of this association for the previous fiscal year and showing the condition of this association at the close of said fiscal year and give or cause to be given all notices as required by law or these By-laws.
- SECTION 6. Treasurer: Treasurer shall have custody of and account for all funds and property of this association. He shall keep complete books and record of all financial transactions of this association. The treasurer shall be the chairman of the finance committee and shall perform such additional duties as maybe required of him by the board of directors.
- SECTION 7. President-Elect: The president-elect shall acquaint himself with the duties of the president and shall contact his committee chairman for the coming year. The president-elect shall ascend to the presidency automatically.
- SECTION 8. **Nominations:** The president shall appoint a nominating committee to be composed of five people, each of whom declares he does not seek a directorship for the elective year in question.

The nominating committee shall nominate one or more members for each directorship position that is vacant as a result of expirations of terms, death, resignation or other cause. Said slate shall be reported to the board of directors at its first meeting in September of each year.

Any member of the corporation in good standing may be nominated as a candidate for director by petition, signed by at least 25 voting members in good standing and received by the secretary, no later than the last working day in September. The board of directors shall accept nominees for the ballot at the first meeting in October.

SECTION 9. Elections: Letter ballots bearing the names of the nominee together with a return envelope shall be mailed by the secretary to all voting members by November 1. Only ballots returned to the secretary at the corporations administrative offices and postmarked prior to December 31st, shall be canvassed. Such date to be specified on the ballot.

The unopened ballots shall be delivered to the nominating committee as appointed by the president. The nominating committee shall count the votes cast for directors and shall determine based upon which nominee received the greatest number or votes cast, which one of the nominees shall fill the vacant directorship positions. The results of the tally shall be reported by letter, to the board of directors. Each nominee shall be notified by the Administrative Office of this corporation within five days after the ratification of the nominating committee report to the board of directors. The board of directors is authorized and empowered to make rules and regulations covering nominations and elections not inconsistant with these By-laws.

SECTION 10. **Assumption of Duties:** The newly elected board of directors shall assume its duties the first day of the fiscal year.

Article IV Board of Directors

- SECTION 1. **Duties of the Board:** The board of directors shall have vested in it the government of the corporation and its control of the corporation's property.
- SECTION 2. Number and Term of Office: The board of directors shall consist of twelve (12) members, elected at large.

In annual elections, four (4) shall be elected for three (3) years and it is the intent of this provision that four (4) members shall be eligible to change on the board of directors each annualized period.

SECTION 3. Quorum and Manner of Acting: A majority of the members of the board of directors shall constitute a quorum at any meeting and the act of a majority of the members present at any meeting at which a quorum is present shall be the act of the board of directors. A director may participate in a meeting by means of a conference telephone or similar communications equipment by means of which all persons participating in the meeting can hear each other, and such participation shall constitute presence at a meeting. The board of directors may also act in writing without a meeting, in

which case the act of a majority of the members shall be the act of the board of directors, provided that such writings shall be filed with the minutes of the proceedings of the board of directors.

- SECTION 4. No Voting by Director having Interest:

 No director having any personal interest which might conflict with the interest of the corporation in any matter coming before its board of directors shall vote as a director in such matter.
- SECTION 5. Vacancies: Whenever any vacancy shall have occurred in the board of directors by reason of death, resignation, removal, increase in the number of directors or otherwise, a majority of the directors then in office, though less than a quorum, may fill such vacancy at any meeting, and the person so elected shall be a director until his successor is elected. The resignation of a director shall be effective upon its receipt by the corporation or a subsequent time as set forth in the notice of resignation. A director may be removed, with or without cause, by a 2/3 vote of the remaining directors; provided, however, that nonpayment of dues in accordance with provisions of Article 1, Section 4, shall result in automatic suspension.
- SECTION 6. Meetings: Meetings of the board of directors may be called by the president. Notice of the time and place as well as the agenda of the meeting shall be given to each member of the board of directors at least ten (10) days in advance of the meeting. Any two (2) members of the board of directors may call such meeting by a written request to the secreatry who shall notify each member of the board of directors in the manner provided in this section.

Article V Committees

- SECTION 1. **General Provisions:** The board of directors shall determine the standing and special committees of the corporation which shall be constituted and shall define the powers and duties of same, and it may at any time abolish any standing or special committee so constituted.
- SECTION 2. Appointment of Committee: The president, with the advice and consent of the board of directors, shall appoint the members of all committees and designate the chairman of each and instruct such committee in their duties. Meetings of committees may be called at anytime by the president or the chairman of the committee.

SECTION 3. Reports: All committees shall make reports periodically to the board of directors and at the annual meeting of the corporation to the membership. Such reports are to be in writing.

Article VI Chapters

- SECTION 1. Formation of Local Chapters: Local chapters of the corporation may be established by the board of directors upon the petition of the members who wish to form a chapter. The petition shall include a chapter name, the signatures of those members desiring to form the chapter and the area to be nonexclusively served by the chapter. The board of directors may exercise its descretion in determining whether or not to grant permission to form the chapter.
- SECTION 2. **Purpose:** The purpose of the chapters shall be to assist the corporation in fulfilling its objectives. The chapter shall actively promote membership in the society. The chapter shall also provide fellowship, guidance and assistance to students and technicians seeking a place in the profession by encouraging them to participate in chapter activities.
- SECTION 3. Local Chapter Status: A local chapter may conduct its business affairs, assess and collect dues, elect its officers, determine its organizational structure, appoint committees and conduct any business conducive to the profession of land surveying; provided, however, that it shall undertake no project or engage in any activity in conflict with the Bylaws or policies of this corporation or in violation of any municipal or county ordinances, the laws of the state of Indiana or those of the United States of America.
- SECTION 4. Meetings: The chapter shall hold at least two meetings throughout the year. A notice and agenda of the meetings shall be mailed to the chapter members and the corporation president at least ten (10) days prior to the meeting.
- SECTION 5. Annual Report: The chapter shall present an annual report to the corporation at the annual meeting containing: The names and addresses of all officers and members; a summary of its activities and financial status.
- SECTION 6. Student Chapters: A student chapter may be established at any accredited or approved educational institution in Indiana upon the submission of a proper petition to the board of directors of this corporation and if the board of directors

finds that sufficient student members of this corporation at the educational institution desire such a student chapter and if the board of directors deem that the best interests of both the educational institution and this corporation will be served by the formation of such a student chapter, a student chapter shall have conferred upon it all rights, privileges and restrictions as set forth in Section 2 of the article.

SECTION 7. Withdrawal from a Local Chapter: An area desiring to withdraw from a local chapter or to form a chapter of its own may do so by following the same procedure as outlined in Section 1 of this article. The board of directors of this corporation may terminate or suspend a chapter at anytime for just cause.

Article VII National Affiliation

This corporation shall be affiliated with the National Society of Professional Surveyors, a member organizations of the American Congress of Surveying and Mapping or its successors.

Article VIII Fiscal Year

The fiscal year of the corporation shall begin on the 1st day of July and end on the 30th day of June of the following year.

Article IX **Amendments**

- SECTION 1. Amendments Generally: These Bylaws may be altered or repealed or new By-laws may be adopted in lieu thereof by the affirmative vote of two-thirds of the whole board of directors at any regular meeting of said board or a special meeting of the board if notice of the proposed alteration, repeal or substitution by contained at a notice to the membership and directors at least ten days prior to such meeting. Provided however, that the board of directors shall not make or alter any By-laws affixing their number, qualifications, classifications or term of office.
- SECTION 2. Amendments Relating to the Board of Directors: Should any amendment to the By-laws relating to the number. qualifications, classifications, or term of office or powers of the board of directors be proposed by a director or member of this corporation, it shall first be submitted to the board of directors and upon its approval submitted to the next annual meeting of members for ratification of the board's approval or submitted to the members at a special meeting of the members as called by the board of directors provided in Article 4 of these By-laws.

He is also survived by eight grandchildren and two great-grandchildren.

ISPLS Library Ready to Use

The 1980 ISPLS board of directors authorized the creation of an ISPLS surveying reference library at ISPLS state headquarters in Indianapolis and budgeted some money to purchase the first selection of books. After a year of activity involving the purchase of books, bookcases, processing, cataloging, shelving, and policy deliberations, the library has been declared ready for the use of Indiana land surveyors.

Almost 200 books and manuals on surveying and related area are presently on hand in the library. Most of the books were purchased from Land-mark Enterprises, Land Surveyors Seminar, and CARBEN Surveying Reprints. Some manuals and handbooks were already on hand at ISPLS headquarters. Others have been donated by members from their personal collections, notably Lloyd Kemmer (22 books) and Ken Curtis (20 books). Another extensive collection of books has been donated by Stephen Burres and is currently being analyzed for inclusion. Other donations are encouraged, particularly of books not listed below. Several new books and new editions will be purchased in the future, as continued budgeting permits. New purchases will be listed in future issues of the *Hoosier Surveyor*.

ISPLS Policy on Check-out of Library Books

- 1. Members are encouraged to use the library by visiting the ISPLS state office, in person, during regular office hours. (Mon., Wed., Fri., 8-4:30 p.m.)
- 2. Only ISPLS members in good standing are eligible to check-out library books for their own personal use.
- 3. Check-out time will be limited to four weeks, with only one extension of time and subject to requests from other members. No user shall have more than three books checked out at any one time.
- 4. Each check-out must be made in person or by letter request. Check-out in person requires no fee. Check-out by mail requires a *prepayment* of a standard fee of \$2.00 per book (which will pay for postage and handling). No phone orders will be accepted. When items are being returned by mail, they are to be sent by USPS or UPS and insured for \$50.00.
- 5. There shall be no defacing of loaned books, expecially any marking or highlighting. Each item will be inspected on return for any damage and then a decision will be made on any assessment of the cost of a replacement copy.

UNSTABLE DRAFTING FILM

If you have used drafting film for plan preparation, you should be alerted that certain brands of this film used during the middle 60's are unstable. It has been reported that the matte surface are showing a tendency to chip and flake off, in many cases eliminating critical plan data thereon.

If you were using drafting film during this era, it would be advisable for you to check your files to see if you have defective film. Some firms have reported all that they have found was a clear sheet of plastic with no images left. Manufacturer of this defective film is not known at this time.

If you have had similar experience with drafting film or can pin-point the manufacturer, the possibility of saving many plans and plats would be greatly enhanced by alerting the profession.

Purdue Professors Outstanding Textbook Authors

Two Purdue professors have made outstanding contributions to surveying literature during the last five years. John McEntyre, professor of land surveying, authored his book, Land Survey Systems in 1978 which was published by John Wiley and Sons. Edward Mikhail, professor of photogrammetry, has authored or co-authored four books. In 1976, he authored the book, Observations and Least Squares, published by IEP. It contained some contributions by F. Ackermann of Stuttgart University. In 1980, he joined with Francis Moffitt, University of California, Berkeley, to revise Moffitt's Photogrammetry for a 3rd edition, published by Harper and Row. In 1980, he and Gordon Gracie, Erindale College, University of Toronto, finished their Analysis and Adjustment of Survey Measurements published by Van Nostrand Reinhold Company. Also in 1981, he and James Anderson, University of California, Berkeley, completed a major revision (the sixth) of the popular text Surveying: Theory and Practice known previously as Davis, Foote, and Kelly published by McGraw-Hill Book Company.

An old time surveyor's observation of many years ago can well be taken today as it did in years gone by. A.C. Mumford in the introduction to his booklet entitled "Boundaries and Landmarks", published in 1912, observed that "No attempt will be made to describe methods of measuring a line; the intention is to furnish suggestions for finding the line which is to be measured. For, after all, when it comes to a question of the stability of property and the peace of the community, it is far more important to have a somewhat faulty measurement of the spot where the line truly exists than it is to have an extremely accurate measurement of the place where the line does not exist at all."


